A. <u>Consideration & Possible Action on Purchasing SCADA system for the Waste Water</u> Treatment Plant.

There are two proposals from Automatic Control Services. Alderman Schoon and Water and Sewer superintendent Mike Mumford are leaning towards proposal #2. Alderman Chesnut brought up how secure this system is. Would someone be able to hack into the system? This will be brought up to Mike to contact Mr. Schmitz regarding the security. Alderman Schoon made a motion to approve the purchase to upgrade the City of Polo Supervisory Control and Data Acquisition (SCADA) system proposal #2, seconded by Alderman Boothe. Mayor Knapp requested the City Clerk call roll on the motion; Alderman Peterson yes, Alderman Grobe yes, Alderman Boothe yes, Alderman Boothe yes, Alderman Schoon yes, and Alderman Busser yes. B. <u>Consideration & Possible Action on the Polo Park Board Recommendation to Increase Various Admissions at the Polo Swimming Pool.</u>

Various increases were presented to the City Council from the Park Board for recommended 2018 pool charges. Alderman Boothe made a motion to accept the park board's recommendation to increase various admissions at the Polo swimming pool, seconded by Alderman Chesnut. Mayor Knapp requested the City Clerk call roll on the motion; Alderman Grobe yes, Alderman Boothe yes, Alderman Chesnut yes, Alderman Schoon yes, Alderman Busser no, and Alderman Peterson yes. The motion carried.

C. Consideration & Possible Action on Economic Growth Corporation from Moline, IL.

Mayor Knapp, Alderman Schoon, Dustin Finkle, Susie Corbitt, and City Clerk Bartelt met with two individuals from the Economic Growth Corporation out of Moline, IL. They are funded by the Illinois treasury department and the Federal treasury department. This company was part of developing the Lawrence Towers in Sterling, IL, Halo in Sterling, IL, and the Holiday Inn in Rock Falls, IL. They help with writing applications to the blight reduction program which would help with demolition of residential properties. They left town and drove by Congress to see if the building would have potential. They would like to know what direction the City of Polo would like to go. Mayor Knapp will contact Amy at Economic Growth Corporation to let her know that he has been in contact with the Illinois Housing Development Authority to let her know we do not know at this time when the next round of funding is and to follow up from their visit last week.

Alderman Busser reported that there will be plenty of room for a street by Rachael Rogers property at 324 W. Jefferson Ave. Attorney Tom Suits will get a vacation ordinance drafted.
